# VOTER BILL OF RIGHTS

## YOU HAVE THE FOLLOWING RIGHTS:

- 1** **The right to vote if you are a registered voter.** You are eligible to vote if you are:
  - a U.S. citizen living in California
  - at least 18 years old
  - registered where you currently live
  - not currently serving a state or federal prison term for the conviction of a felony, and
  - not currently found mentally incompetent to vote by a court
- 2** **The right to vote if you are a registered voter even if your name is not on the list.** You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.
- 3** **The right to vote if you are still in line when the polls close.**
- 4** **The right to cast a secret ballot** without anyone bothering you or telling you how to vote.
- 5** **The right to get a new ballot if you have made a mistake,** if you have not already cast your ballot. You can:
  - Ask an elections official at a polling place** for a new ballot,
  - Exchange your vote-by-mail ballot** for a new one at an elections office, or at your polling place, or
  - Vote using a provisional ballot.**
- 6** **The right to get help casting your ballot** from anyone you choose, except from your employer or union representative.
- 7** **The right to drop off your completed vote-by-mail ballot at any polling place** in California.
- 8** **The right to get election materials in a language other than English** if enough people in your voting precinct speak that language.
- 9** **The right to ask questions to elections officials about election procedures** and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- 10** **The right to report any illegal or fraudulent election activity** to an elections official or the Secretary of State's office.

## Top Contributors to State Candidates

When a committee (a person or group of people who receive or spend money for the purpose of influencing voters to support or oppose candidates) supports or opposes a candidate and raises at least \$1 million, the committee must report its top 10 contributors to the California Fair Political Practices Commission (FPPC). The committee must update the top 10 list when there is any change.

## Two U.S. Senate Contests on Ballot

The office of U.S. Senate will have TWO separate contests on the June 7, 2022, Primary Election ballot. You may vote on both.

The first contest is the regular election for the full 6-year term of office beginning on January 3, 2023 (full term).

The second contest is a special vacancy election, since the current officeholder is temporarily filling a vacancy, for the remainder of the term ending on January 3, 2023 (partial/unexpired term).

This Voter Information Guide can help you make informed decisions and prepare for the June 7, 2022, Primary Election. The following pages include election deadlines, voter registration information, candidate statements, your rights as a California voter, and other useful information. For additional election information, you can visit [vote.ca.gov](https://vote.ca.gov) or call toll-free (800) 345-VOTE (8683).

**New District Lines**—California's June 7, 2022, Primary Election will be the first opportunity for you to vote for candidates in the newly drawn Congressional, State Assembly, State Senate, Board of Equalization, County Supervisorial, and City Council Districts. Until the newly elected officials take office after the November 2022 General Election, the existing district boundaries remain in effect, and constituents will continue to be represented by the elected officials occupying those offices. For more information on the new district lines, visit the website of your local elections office.

**Vote By Mail Now Permanent**—After its success in the 2020 General Election and the 2021 Gubernatorial Recall Election, the Legislature passed AB 37 which ensures every actively registered voter will be sent a vote-by-mail ballot with the option to return their ballot by mail, at a secure drop box, or in person. Whichever option you choose, remember to sign your ballot before you return it!

**Track Your Ballot**—Never wonder whether your vote is counted. You can track your vote-by-mail ballot by signing up at [WheresMyBallot.sos.ca.gov](https://WheresMyBallot.sos.ca.gov) to receive text, email, or voice status alerts.

**More Voter's Choice Act Counties**—California is adding 13 more Voter's Choice Act (VCA) counties in 2022 for a total of 27. In addition to universal vote by mail, VCA counties offer more days and more ways to vote in person. **Make A Plan To Vote**—Voting matters. But to vote, you need to make a plan. Will you vote by returning your signed ballot by mail in the envelope provided? Will you drop it at a vote center or drop box? Or will you vote in person at a neighborhood polling place or vote center? Research your options and make a plan today!

**In California, you will automatically receive a ballot before every election.** Living in a Voter's Choice Act (VCA) county means more options when it comes to voting.

#### Vote by mail:

Return your ballot by mail **as soon as you receive it!**

#### Use a drop box:

Return your ballot to a secure drop off location **up to 28 days before the election.**

#### Vote in person:

- Vote in person anywhere in the county **up to 10 days before the election.**
- Register to vote and vote same day.
- Drop off your ballot.

# VOTE SAFE at Early Voting Locations

One or more early voting locations will be available in many counties beginning before the **June 7, 2022**, election. Voting locations will offer voter registration, replacement ballots, accessible voting machines, and language assistance.

You can help keep voting locations safe for voters and election workers in these two ways:

1

## Skip the line.

You can return completed ballots **by mail** with no stamp needed, at a secure **ballot drop box**, or at a **voting location**. Voting locations will have separate lines for voters dropping off completed ballots.

## Vote early.

If you visit a voting location in person, go before Election Day. One or more voting locations in many counties will be open prior to Election Day.

Elections offices will begin sending vote-by-mail ballots to California voters no later than **May 9, 2022**. Ballots returned by mail must be postmarked by **June 7, 2022**; ballots returned at a secure ballot drop box must be deposited by 8:00 p.m. on **June 7, 2022**.

---

## Find Your Polling Place or a Vote Center

Polling places and vote centers are established by county elections officials. Look for your polling place address or vote center locations in the county Voter Information Guide that you receive in the mail a few weeks before Election Day.

You may also visit the Secretary of State's website at [vote.ca.gov](https://vote.ca.gov) or call the toll-free Voter Hotline at (800) 345-VOTE (8683).

You can also text "Vote" to GOVOTE (468683) to find the location of your polling place or nearest vote center.

---

## Same Day Voter Registration

Did you forget to register or update your voter registration? No problem! You can register to vote and vote until 8:00 p.m. on Election Day at your county elections office or at any vote center or polling place in your county. This process is called Conditional Voter Registration and is commonly referred to as Same Day Voter Registration. Here's how it works:

1. Visit your county elections office, a vote center, or polling place in your county which can be found in your county Voter Information Guide or at [vote.ca.gov](https://vote.ca.gov).
2. Complete a voter registration card or an online application.
3. Vote your ballot at your county elections office, vote center, or polling place.
4. Once the county elections official processes your registration, and determines you are eligible, you will be registered to vote and your ballot will be counted.

## **WheresMyBallot.sos.ca.gov**

When you sign up for “Where’s My Ballot?” you will receive automatic updates when your county elections office:

- Mails your ballot.
- Receives your ballot.
- Counts your ballot.
- Finds an issue with your ballot.

## **Postage Prepaid Ballots**

“No Stamp, No Problem”—All California vote-by-mail ballot return envelopes have prepaid postage, ensuring that voting is free and convenient for all California voters. After you have filled out your vote-by-mail ballot, place it in the return envelope, seal the envelope, sign on the designated line, and put it into the mailbox. You may also drop your ballot off at a secure drop box, polling place, vote center, or county elections office by 8:00 p.m. on June 7, 2022.

## Statewide Constitutional Offices

California law includes voluntary spending limits for candidates running for state office who choose to keep their campaign expenses under specified dollar amounts. Statewide constitutional office candidates may buy space for a candidate statement (up to 250 words) in this voter guide if they accept the voluntary spending limits.

Voluntary spending limits for the following offices for the June 7, 2022, Primary Election are:

- Governor—\$9,728,000
- Lieutenant Governor, Secretary of State, Controller, Treasurer, Attorney General, Insurance Commissioner, and Superintendent of Public Instruction—\$6,485,000
- Member of the Board of Equalization—\$1,621,000



# Tips for California's Military and Overseas Voters

Taking part in elections is more convenient than ever for Californians serving in the military or living outside the United States. It begins when you register to vote as a military or overseas voter and receive election materials by mail, fax, or email.

- **Start early.** County elections officials' last day to send ballots to military and overseas voters is 45 days before Election Day. Fill out a voter registration application early at [RegisterToVote.ca.gov](https://RegisterToVote.ca.gov) to ensure that you receive your ballot by Election Day.
- **Know your options.** When registering to vote as a military or overseas voter, you can choose to have your ballot mailed, faxed, or emailed to you. Additionally, you may visit your county elections official's website for information on how to download your ballot and election materials. You may return your voted ballot to your county elections official by mail or, in certain circumstances, by fax. If you meet the requirements to return your ballot by fax, you must also fax the Oath of Voter form (available from your county elections official) waiving your right to a confidential ballot.
- **Stay in touch.** Once you register as a military or overseas voter, you will continue to receive a ballot and election materials from your county elections official before each election. However, you will need to update your registration to vote if you change your address, your name, or your political party preference, or if you do not participate in four consecutive statewide general elections. Visit [sos.ca.gov/elections/voter-registration/military-overseas-voters/](https://sos.ca.gov/elections/voter-registration/military-overseas-voters/) for more election resources designed especially for you.

## Dates to remember:

**May 23:** Last day for military or overseas voters to register to vote and request a ballot.

**May 31:** Last day for military or overseas voters to update or change how they want to receive their ballot.

**June 7:** Election Day. Mailed ballots must be postmarked on or before Election Day **and** received by your county elections office no later than **June 14**. Faxed ballots must be delivered to your county elections office no later than 8:00 p.m. Pacific Daylight Time on Election Day.

# Voter Registration

If you have already registered to vote, you do not need to re-register **unless** you change your name, home address, or mailing address, or if you want to change or select a political party. You can register to vote online at [registertovote.ca.gov](http://registertovote.ca.gov) or call the Secretary of State's toll-free Voter Hotline at (800) 345-VOTE (8683) to get a form mailed to you.

Voter registration forms can be found at most post offices, libraries, city and county government offices, county elections offices, and the California Secretary of State's office.

## Conditional Voter Registration

During the period of 14 days prior to Election Day and including Election Day, you can go to the office of your county elections official, a vote center, or polling place to conditionally register to vote and vote. # Voter Registration Privacy Information

**Safe at Home Confidential Voter Registration Program:** Certain voters facing life-threatening situations (i.e., victims and survivors of domestic violence, stalking, sexual assault, human trafficking, elder/dependent adult abuse) may qualify for confidential voter status if they are active members of the Safe at Home program. 
**Voter Information Privacy:** Information on your voter registration affidavit will be used by elections officials to send you official information on the voting process, such as the location of your polling place, and the measures and candidates that will appear on the ballot. Commercial use of voter registration information is prohibited by law and is a misdemeanor. Voter information may be provided to a candidate for office, a ballot measure committee, or other person for election, scholarly, journalistic, political, or governmental purposes, as determined by the Secretary of State. Driver license and social security numbers, or your signature as shown on your voter registration card, cannot be released for these purposes. If you have any questions about the use of voter information or wish to report suspected misuse of such information, please call the Secretary of State's toll-free Voter Hotline at (800) 345-VOTE (8683).

# New to voting? Get started with 3 easy steps!

## 1. Register!

Register to vote by **May 23, 2022**. You can register online at [registertovote.ca.gov](https://registertovote.ca.gov) or have a voter registration form mailed to you by calling the Secretary of State's toll-free Voter Hotline at (800) 345-VOTE (8683). You can also pick up a voter registration form at your county elections office, local post office, or library.

You can “conditionally” register and vote (commonly referred to as Same Day Voter Registration) at your county elections office or any voting location after the 15-day voter registration deadline. Visit [vote.ca.gov](https://vote.ca.gov) or see page 6 of this guide for more information.

You are eligible to register to vote and vote in California if you are a U.S. citizen, at least 18 years of age on Election Day, not currently serving a state or federal prison term for the conviction of a felony, and not currently found mentally incompetent to vote by a court.

## 2. Get informed!

As a registered voter you will receive two information resources in the mail:

- The county Voter Information Guide, which contains a sample ballot, your polling place location, and other helpful information.

## 3. Vote!

You can vote by mail or in person.



**By mail or drop box:** Every active, registered voter in California will be mailed a ballot for the June 7, 2022, Primary Election. Vote-by-mail ballots must be postmarked on or before Election Day and received no later than 7 days after Election Day. Or, you may personally deliver your ballot to any polling or ballot drop-off location in California by 8:00 p.m. on Election Day.



**In person:** Polling locations are established by county elections officials and are open from **7:00 a.m. to 8:00 p.m. on Election Day, Tuesday, June 7, 2022**. To vote early before Election Day, contact your county elections office (see page 59 of this guide for county contact information) or visit [caearlyvoting.sos.ca.gov](https://caearlyvoting.sos.ca.gov).

**Option for voters with disabilities:** Counties offer an accessible voting option called remote accessible vote-by-mail (RAVBM). RAVBM allows voters with disabilities to receive their ballots at home and mark them independently and privately before sending them back to elections officials.

# WARNING: ELECTIONEERING PROHIBITED!

---

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT.

---

## WHERE:

- Within the immediate vicinity of a person in line to cast their ballot or within 100 feet of the entrance of a polling place, curbside voting or drop box the following activities are prohibited.

## WHAT ACTIVITIES ARE PROHIBITED:

- **DO NOT** ask a person to vote for or against any candidate or ballot measure.
- **DO NOT** display a candidate's name, image, or logo.
- **DO NOT** block access to or loiter near any ballot drop boxes.
- **DO NOT** provide any material or audible information for or against any candidate or ballot measure near any polling place, vote center, or ballot drop box.
- **DO NOT** circulate any petitions, including for initiatives, referenda, recall, or candidate nominations.
- **DO NOT** distribute, display, or wear any clothing (hats, shirts, signs, buttons, stickers) that include a candidate's name, image, logo, and/or support or oppose any candidate or ballot measure.
- **DO NOT** display information or speak to a voter about the voter's eligibility to vote.

The electioneering prohibitions summarized above are set forth in Article 7 of Chapter 4 of Division 18 of the California Elections Code.

# WARNING: CORRUPTING THE VOTING PROCESS IS PROHIBITED!

---

VIOLATIONS SUBJECT TO FINE AND/OR IMPRISONMENT.

---

## WHAT ACTIVITIES ARE PROHIBITED:

- **DO NOT** commit or attempt to commit election fraud.
- **DO NOT** provide any sort of compensation or bribery to, in any fashion or by any means induce or attempt to induce, a person to vote or refrain from voting.
- **DO NOT** illegally vote.
- **DO NOT** attempt to vote or aid another to vote when not entitled to vote.
- **DO NOT** engage in electioneering; photograph or record a voter entering or exiting a polling place; or obstruct ingress, egress, or parking.
- **DO NOT** challenge a person's right to vote or prevent voters from voting; delay the process of voting; or fraudulently advise any person that he or she is not eligible to vote or is not registered to vote.
- **DO NOT** attempt to ascertain how a voter voted their ballot.
- **DO NOT** possess or arrange for someone to possess a firearm in the immediate vicinity of a polling place, with some exceptions.
- **DO NOT** appear or arrange for someone to appear in the uniform of a peace officer, guard, or security personnel in the immediate vicinity of a polling place, with some exceptions.
- **DO NOT** tamper or interfere with any component of a voting system.
- **DO NOT** forge, counterfeit, or tamper with the returns of an election.
- **DO NOT** alter the returns of an election.
- **DO NOT** tamper with, destroy, or alter any polling list, official ballot, or ballot container.
- **DO NOT** display any unofficial ballot collection container that may deceive a voter into believing it is an official collection box.
- **DO NOT** tamper or interfere with copy of the results of votes cast.
- **DO NOT** coerce or deceive a person who cannot read or an elder into voting for or against a candidate or measure contrary to their intent.
- **DO NOT** act as an election officer when you are not one.

**EMPLOYERS** cannot require or ask their employee to bring their vote by mail ballot to work or ask their employee to vote their ballot at work. At the time of payment of salary or wages, employers cannot enclose materials that attempt to influence the political opinions or actions of their employee.

**PRECINCT BOARD MEMBERS** cannot attempt to determine how a voter voted their ballot or, if that information is discovered, disclose how a voter voted their ballot.

The prohibitions on activity related to corruption of the voting process summarized above are set forth in Chapter 6 of Division 18 of the California Elections Code.

# Elections in California

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still must be held.

California's open primary system does not apply to candidates running for U.S. President, county central committee, or local offices.

Write-in candidates for voter-nominated offices can still run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election. Additionally, there is no independent nomination process for a general election.

California law requires the following information to be printed in this guide.

## Voter-Nominated Offices

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election. A candidate for nomination to a voter-nominated office shall have their qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party. In the county voter information guide, parties may list the candidates for voter-nominated offices who have received the party's official endorsement.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation move on to the general election, unless the candidate is one of the two highest vote-getters at the primary election.

## Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election. A candidate for nomination to a nonpartisan office may not designate their party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

# Provisional Voting

If your name is not on the voter list at your polling place or vote center, you have the right to vote a provisional ballot.

## What is a provisional ballot?

A provisional ballot is a regular ballot that is placed in a special envelope prior to being put in the ballot box.

## Who casts a provisional ballot?

Provisional ballots are ballots cast by voters who believe they are registered to vote even though their names are not on the official voter registration list at the polling place or vote center.

Voters may need to cast provisional ballots if the voter wants to vote in person at a polling place or vote center but did not receive their ballot or does not have their ballot with them.

## Will my provisional ballot be counted?

Your provisional ballot will be counted after elections officials have confirmed that you are registered to vote in that county and you did not already vote in that election.

You may vote a provisional ballot at any polling place or vote center in the county in which you are registered to vote; however, only the election contests you are eligible to vote for will be counted.

## How can you check the status of your provisional ballot?

Every voter who casts a provisional ballot has the right to find out from their county elections official if the ballot was counted and, if not, the reason why it was not counted.

# Assistance for Voters with Disabilities

California is committed to ensuring every voter can cast their ballot privately and independently.

## Voting at a Polling Place or Vote Center

If you need help marking your ballot, you may choose up to two people to help you. This person cannot be:

- your employer or anyone who works for your employer
- your labor union leader or anyone who works for your labor union

*Curbside voting* allows you to park as close as possible to the voting area. Elections officials will bring you a roster to sign, a ballot, and any other voting materials you may need, whether you are actually at a curb or in a car. Contact your county elections office to see if curbside voting is available at your polling place or vote center.

All polling places and vote centers are required to be accessible to voters with disabilities and will have accessible voting machines.

## Voting at Home

Remote accessible vote-by-mail (RAVBM) systems provide an accessible option for voters with disabilities to receive their ballots at home and mark them independently and privately before sending them back to elections officials. Contact your county elections official for more information.



# VOTE SAFE With Your Vote-By-Mail Ballot

Elections offices will begin sending vote-by-mail ballots to California voters no later than **May 9, 2022**. Ballots returned by mail must be postmarked by **June 7, 2022**; ballots returned at a secure ballot drop box must be deposited by 8:00 p.m. on **June 7, 2022**.



## Voting by mail is SAFE and EASY.

After marking your choices on your ballot, simply:

- Seal it.**  
Secure your ballot inside the envelope from your county elections office.
