Dear Riverside County Voter,

Election Day is March 5, 2024. This County Voter Information Guide provides ballot marking instructions, candidate information and other important election information that you should review before you vote. You may mark your selections on your Sample Ballot and take it with you to any Vote Center for easy reference. Each eligible registered voter for the March 5, 2024, Presidential Primary Election will receive a ballot by mail beginning Monday, February 5, 2024.

Voters can verify their voter registration at voterstatus.sos.ca.gov or register to vote at registertovote.ca.gov.

- Your Vote-by-Mail ballot may be returned at any secure Ballot Drop-off location that will be available beginning February 5, 2024, or via USPS (no postage required).
- You may drop off your voted ballot at any designated Ballot Drop-off location or Vote Center in Riverside County before Election Day. Please visit www.voteinfo.net for a list of participating locations and hours, or you may call our office at the numbers listed.
- For your ballot to count, it must be in the possession of the Riverside County Registrar of Voters or an elections official at any Vote Center, Ballot Drop-off location, or Polling Place within the state by the close of polls on Election Day, March 5, 2024. Your ballot will also count if it is postmarked on or before Election Day and received no later than seven days after Election Day.
- You may track your ballot by registering at WheresMyBallot.sos.ca.gov.

Early Voting – There are more days and more ways to vote. Vote at the Registrar of Voters Office beginning February 5 - March 4 (excluding Holidays), Monday through Friday, 8:00 a.m. to 5:00 p.m.; February 24 - February 25 and March 2 - March 3, 9:00 a.m. to 5:00 p.m.; and Election Day, March 5, 7:00 a.m. to 8:00 p.m. Please visit our website at www.voteinfo.net for early voting locations and information.

Vote on Election Day March 5 – All Vote Centers, including the Registrar of Voters office, will be open on Election Day, March 5, from 7:00 a.m. to 8:00 p.m. Riverside County voters can vote in-person at any Vote Center in the County. Note that the registration deadline to vote or change your political party preference is February 20, 2024. Consult the County Voter Information Guide for more information. Please feel free to contact the Riverside County Registrar of Voters at (951) 486-7200 with any questions or concerns regarding the upcoming March 5, 2024, Presidential Primary Election.

HOW TO VOTE FOR PRESIDENT

Registered to Vote with No Party Preference/No Party?

As a voter who declined to provide a political party preference, or you registered with an unknown or unqualified political party, you are considered a “No Party Preference” (NPP) voter, and **your primary election ballot will not have presidential candidates on it.**

If you want to vote for U.S. President, you must request a ballot with presidential candidates from one of the following parties:

- American Independent Party
- Democratic Party
- Libertarian Party

If you want to vote for the Green, Peace and Freedom, or Republican parties' presidential candidates, you must re-register with that specific party.

To re-register to vote online, go to registertovote.ca.gov. If you need to re-register after February 20, 2024, you can do so in person at any vote center in Riverside County, or at the Registrar of Voters Office.

Registered to Vote with a Qualified Political Party?

If you registered with any of the following qualified political parties, you can only vote for that party's presidential candidates:

- American Independent Party
- Democratic Party
- Green Party
- Libertarian Party
- Peace and Freedom Party
- Republican Party

If you want to vote for another party's presidential candidate, you must re-register with that specific party.

You can re-register to vote online at registertovote.ca.gov. If you need to re-register after February 20, 2024, you can do so in person at any vote center in Riverside County, or at the Registrar of Voters Office.

Elections in California

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Previously known as partisan offices, voter-nominated offices include state legislative offices and United States congressional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still must be held.

California's open primary system does not apply to candidates running for United States President, county central committee, or local offices.

Write-in candidates for voter-nominated offices may still run in the primary election. However, a write-in candidate may only move on to the general election if the candidate is one of the top two vote-getters in the primary election. Additionally, there is no independent nomination process for a general election.

California law requires the following information to be printed in this guide.

Party-Nominated/Partisan Offices

Political parties may formally nominate candidates for party-nominated/partisan offices at the primary election. A nominated candidate will represent that party as its official candidate for the specific office at the general election and the ballot will reflect an official designation. The top vote-getter for each party at the primary election moves on to the general election. Parties also elect officers of county central committees at the primary election.

A voter can only vote in the primary election of the political party he or she has disclosed a preference for upon registering to vote. However, a political party may allow a person who has declined to disclose a party preference to vote in that party's primary election.

Voter-Nominated Offices

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election. A candidate for nomination to a voter-nominated office shall have his or her qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party. In the county voter information guide, parties may list the candidates for voter-nominated offices who have received the party's official endorsement.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation move on to the general election unless the candidate is one of the two highest vote-getters at the primary election.

Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election. A candidate for nomination to a nonpartisan office may not designate his or her party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

HOW TO USE THIS SAMPLE BALLOT

1. **POLITICAL PARTY PREFERENCE:** If you are not sure about your political party preference, look at the front of this booklet. You may check your political party preference on our website at www.voteinfo.net by selecting *My Voter Status* or by calling (951) 486-7200. If you chose a political party preference when registering to vote you will be issued an official ballot which will include that political party's U.S. Presidential and central committee candidates. Voter-Nominated and Nonpartisan contests will also be included.
2. **NO PARTY PREFERENCE AND NONPARTISAN:** If you did not indicate a political party preference or you registered with an unqualified political party, then you will be issued the **No Party Preference / Nonpartisan** ballot. Your ballot will include congressional, state legislative, and nonpartisan contests, **not U.S. Presidential Candidates**. However, for this election, three parties are allowing cross over voting for their Presidential Candidates. You may request one of the following ballots:

3. **PARTY-NOMINATED OFFICES IN THE SAMPLE BALLOT**

All voters are eligible to vote on the voter-nominated and nonpartisan portion of the ballot. Following the party sample ballot pages are the voter-nominated and nonpartisan offices, and state and local propositions and measures. The exact issues and offices on your ballot correspond to the location of your residence address, according to what jurisdictions have seats to fill and/or questions to ask.

Two U.S. Senate Contests on Ballot

There are two U.S. Senate contests on the March 5, 2024, Presidential Primary Election ballot.

The first contest is the regular election for the full 6-year term ending January 3, 2031.

The second contest is a special vacancy election (the current officeholder is temporarily filling a vacancy) for the remainder of the current term ending January 3, 2025.

"To upgrade classrooms, science labs, career-training facilities, and instructional technology to support college/career readiness in math, science, technology, engineering, arts/skilled trades; safeguard student safety; fix deteriorating roofs, plumbing, electrical, ventilation systems; repair, construct, acquire classrooms, facilities, sites/equipment; shall Desert Sands Unified School District's measure authorizing \$675,000,000 in bonds at legal interest but **without increasing current tax rates** be adopted, levying \$60 per \$100,000 assessed value (\$45,000,000 annually) while bonds are outstanding, with citizen oversight/audits?"

PROJECT LIST

The Board of Education of the Desert Sands Unified School District is committed to providing safe, secure, upgraded classrooms, labs and technology needed to support high quality instruction **in math, science, engineering and technology** which will prepare students for **college and in-demand jobs** in fields like health sciences, engineering, technology, and skilled trades. To that end, the Board evaluated the condition of older schools and the District's urgent and critical technology and facility needs, including **safety** issues, class size reduction, **basic repairs**, computer and information technology in developing the types of projects to be funded by this measure as described below. The District conducted a facilities evaluation, prepared a 2022 Long Range Facilities Master Plan, and received public input in developing this Project List. Teachers, staff, community members and the Board have prioritized the key health and safety needs so that the most critical facility needs are addressed.

In approving this Project List, the Board of Education determines that the District **must**:

- (i) **Provide classrooms, facilities, technology needed to support high quality instruction in math, science, engineering, and technology; and**
- (ii) **Make repairs to older classrooms, school facilities including deteriorating roofs, plumbing, sewer, heating, ventilation, and electrical systems; and**
- (iii) **Remove hazardous materials like asbestos, lead pipes from older school sites, where encountered; and**
- (iv) **Provide modern labs, career technical facilities, equipment so students are prepared for college, in-demand careers in fields like health sciences, engineering, technology, skilled trades; and**
- (v) **Improve student safety, campus security systems including security fencing, cameras, emergency communications systems, smoke detectors, fire alarms, and sprinklers.**

The Project List includes the following types of upgrades and improvements at schools, facilities and sites within the District:

REPAIR OLDER SCHOOLS AND IMPROVE THE QUALITY OF EDUCATION

School Repair and Upgrade Projects Funded By Money That Cannot Be Taken By The State

Goal and Purpose:

Some schools were built 50+ years ago and many of them need to be modernized requiring the District makes priority repairs and improvements so schools can continue to serve community well for decades to come.

- **Make repairs to older classrooms and school facilities including deteriorating roofs, plumbing, sewer, heating, ventilation, and electrical systems.**
- **Build shade structures and indoor eating areas so students are protected from the heat and sun on hot days.**
- **Upgrade older schools so they meet current health codes and building safety codes and provide proper access for students with disabilities.**
- **Remove hazardous materials like asbestos and lead pipes from older school sites.**

STUDENT SAFETY AND ACHIEVEMENT: LOCAL SCHOOL FUNDING TO SUPPORT HIGH QUALITY INSTRUCTION IN MATH, SCIENCE, ENGINEERING AND TECHNOLOGY

Projects That Improve Student Safety and Success

Goals and Purposes:

If we want students to succeed in college and careers, they must be skilled in the use of today's technologies and have advanced classes in science, math, engineering and technology. This measure will make this possible.

Some of our schools have modern classrooms, labs and educational facilities, while others don't. This measure will ensure that ALL students have equal access to classrooms, labs and facilities they need to succeed.

- **Provide classrooms, facilities and technologies needed to support high quality instruction in math, science, engineering and technology.**
- Provide modern labs, career technical facilities and equipment so students are prepared for college, and in-demand careers in fields like health sciences, engineering, technology and skilled trades.
- **Improve student safety and campus security systems including security fencing, cameras, emergency communications systems, smoke detectors, fire alarms, and sprinklers.**
- Upgrade classrooms and computer systems to keep pace with technology.
- Add or construct classrooms and facilities, where needed, to relieve overcrowding.

In addition to the projects listed above, the repair and renovation of the District's existing schools and facilities, may include, but not be limited to, some or all of the following: add or renovate student and staff restrooms; repair and replace electrical, plumbing, lighting, heating, ventilation and air conditioning systems; upgrade of facilities for energy efficiencies, including EV charging stations and solar panels; repair and replace worn-out and deteriorated roofs, windows, walls, floors, doors and drinking fountains; construct or renovate offices and facilities for professional development of teachers, more efficient administration and multi-purpose learning spaces and libraries; install wiring and electrical systems to safely accommodate computers, technology and other electrical devices, including emergency generators; upgrade or construct support facilities including administrative, physical education, music, art, visual and performing and fine arts classrooms or facilities, outdoor amphitheaters, science, computer labs/classrooms, auditoriums, libraries and buildings, swing space, covered eating areas, shade structures, maintenance and operations facilities and yards; repair and replace fire alarms, fire alarm detection, emergency communications and security systems; improve facilities to satisfy ADA requirements; resurface or replace asphalt, broken concrete and improve hard courts, turf and irrigation/drainage systems, all-weather outdoor tracks and campus landscaping; install signage, and fencing; expand parking and drop-off areas; improve all site utilities; acquire land; construct new school buildings, classrooms and libraries; upgrade or replace interior and exterior painting, floor covering (including carpets), portable classrooms and school facades; demolition; upgrade central and finishing kitchens, food service, and school cafeterias; construct various forms of storage and support spaces and classrooms; acquire robotics equipment; improve outdoor learning environments and quads; repair, upgrade and install interior and exterior lighting systems; construct, acquire or improve playgrounds, play structures, athletic fields, tennis, handball and basketball courts, gymnasiums, tracks and facilities to support student health, fitness and safety, lockers, and other facilities serving District students; replace outdated security fences and security systems (including access control systems), provide lunch shelters, upgrade music, art, performing arts and vocational education classrooms, multi-purpose rooms, learning, media, fitness and wellness centers; add or upgrade parking lots. In addition to the listed projects stated above, the Project List also includes the acquisition of a variety of instructional, maintenance and operational equipment, including the reduction or retirement of outstanding lease obligations and interim funding incurred to advance fund projects from the Project List; payment of the costs of preparation of all facility planning, facility studies, assessment reviews, facility master plan preparation and updates, environmental studies (including environmental investigation, remediation and monitoring), design and construction documentation, and temporary housing of dislocated District activities caused by construction projects.

The upgrading of technology infrastructure includes, but is not limited to, network rewiring, cabling, access points, computers, mobile interface devices, data centers, main distribution frame, switches, routers, modules, power supply, data storage, sound projection systems, public address systems, phone communication systems, data/voice network system, laser printers, digital white boards, document projectors, upgrade voice-over-IP, clock/telephone/ intercom systems, call manager and IT security, wireless technology systems, refresh classroom technology, acquire necessary software and miscellaneous IT and instructional equipment, data storage, phones, identity cards and the construction and installation of a data center in the cloud for the District enterprise systems, such as resource planning, websites, domain name systems, cloud applications and information security.

The budget for each project is an estimate and may be affected by factors beyond the District's control. The final cost of each project will be determined as plans and construction documents are finalized, construction bids are received, construction contracts are awarded and projects are completed. Based on the final costs of each project, certain of the projects described above may be delayed or may not be completed. Demolition of portable classrooms and existing facilities and reconstruction of facilities scheduled for repair and upgrade may occur, if the Board determines that such an approach would be more cost-effective in creating more enhanced and operationally efficient campuses. Necessary on-site and off-site improvements, site preparation and restoration may occur in connection with new construction, renovation or remodeling, or installation or removal of relocatable classrooms, including ingress and egress, removing, replacing, or installing irrigation or drainage systems, traffic signals, sewer or utility lines, trees and landscaping, relocating fire access roads, road widening, and acquiring any necessary easements, licenses, permits or rights of way to the property. The listed projects will be completed as needed. Each project is assumed to include its share of furniture, equipment, architectural, engineering, legal fees and similar planning costs, connection fees, permit fees, program/project management, staff training expenses and a customary contingency for unforeseen design and construction costs. Proceeds of the bonds may be used to pay or reimburse the District for the cost of District staff when performing work on or necessary and incidental to bond projects. Bond proceeds shall only be expended for the types of projects and purposes identified herein. The District shall create an account into which proceeds of the bonds shall be deposited and comply with the reporting requirements of Government Code § 53410.

FISCAL ACCOUNTABILITY: THIS MEASURE REQUIRES A CLEAR SYSTEM OF ACCOUNTABILITY, INCLUDING A PROJECT LIST DETAILING HOW THE MONEY WILL BE USED, AN INDEPENDENT CITIZEN'S OVERSIGHT COMMITTEE, AND INDEPENDENT AUDITS TO ENSURE MONEY IS SPENT PROPERLY.

IN ACCORDANCE WITH EDUCATION CODE SECTION 15272, THE BOARD OF EDUCATION WILL APPOINT A CITIZENS' OVERSIGHT COMMITTEE AND CONDUCT ANNUAL INDEPENDENT AUDITS TO ASSURE THAT FUNDS ARE SPENT ONLY ON DISTRICT PROJECTS AND FOR NO OTHER PURPOSE. THE EXPENDITURE OF BOND MONEY ON THESE PROJECTS IS SUBJECT TO STRINGENT FINANCIAL ACCOUNTABILITY REQUIREMENTS. BY LAW, PERFORMANCE AND FINANCIAL AUDITS WILL BE PERFORMED ANNUALLY, AND ALL BOND EXPENDITURES WILL BE MONITORED BY AN INDEPENDENT CITIZENS' OVERSIGHT COMMITTEE TO ENSURE THAT FUNDS ARE SPENT AS PROMISED AND SPECIFIED. THE CITIZENS' OVERSIGHT COMMITTEE MUST INCLUDE, AMONG OTHERS, REPRESENTATION OF A BONA FIDE TAXPAYERS ASSOCIATION, A BUSINESS ORGANIZATION AND A SENIOR CITIZENS ORGANIZATION. NO DISTRICT EMPLOYEES OR VENDORS ARE ALLOWED TO SERVE ON THE CITIZENS' OVERSIGHT COMMITTEE.

NO ADMINISTRATOR SALARIES: PROCEEDS FROM THE SALE OF THE BONDS AUTHORIZED BY THIS MEASURE SHALL BE USED ONLY FOR THE ACQUISITION, CONSTRUCTION, RECONSTRUCTION, REHABILITATION, OR REPLACEMENT OF SCHOOL FACILITIES, INCLUDING THE FURNISHING AND EQUIPPING OF SCHOOL FACILITIES, AND NOT FOR ANY OTHER PURPOSE, INCLUDING TEACHER AND SCHOOL ADMINISTRATOR SALARIES AND OTHER OPERATING EXPENSES.

**MEASURE "A" - DESERT SANDS UNIFIED SCHOOL DISTRICT
GENERAL OBLIGATION BONDS
TAX RATE STATEMENT**

An election will be held in Desert Sands Unified School District (the "District") on March 5, 2024 for the purpose of submitting to the electors of the District the question of incurring bonded indebtedness of the District in the principal amount of \$675 million. If such bonds are authorized and sold, the principal thereof and interest thereon will be payable from the proceeds of taxes levied on the taxable property in the District. The following information regarding tax rates is given in compliance with Section 9401 of the California Elections Code. This information is based upon the best estimates and projections presently available from official sources, upon experience within the District and other demonstrable factors.

Based upon the foregoing and projections of the assessed valuations of taxable property in the District, and assuming the entire debt service on the bonds will be paid through property taxation:

1. The best estimate of the average annual tax rate that would be required to be levied to fund the bond issue over the entire duration of the bond debt service, based on assessed valuations available at the time of the filing of this statement, or a projection based on experience within the same jurisdiction or other demonstrable factors is \$49 per \$100,000 of assessed valuation of all property to be taxed. It is estimated that the final fiscal year in which the tax is anticipated to be collected is 2053-54.

2. The best estimate of the highest tax rate that would be required to be levied to fund the bond issue, and an estimate of the year in which that rate will apply, based on estimated assessed valuations available at the time of the filing of this statement, or a projection based on experience within the same jurisdiction or other demonstrable factors, is \$60 per \$100,000 of assessed valuation of all property to be taxed and the year is 2044-45.

3. The best estimate of the total debt service, including the principal and interest, that would be required to be repaid if all the bonds are issued and sold is approximately \$1,371,994,476.

Attention of voters is directed to the fact that the foregoing information is based upon projections and estimates only. The actual timing of sales of the bonds and the amount to be sold at any time will be governed by the needs of the District and other factors. The actual interest rates at which the bonds will be sold, which will not exceed the maximum permitted by law, will depend upon the bond market at the time of sale. The actual assessed valuations in future years will depend upon the value of property within the District as determined in the assessment and the equalization process. Assessed valuation is not the same as market price of real property. Therefore, the actual tax rates and the years in which those tax rates will be applicable may vary from those presently estimated and stated above.

Voters should note that estimated tax rates are based on the *ASSESSED VALUE* of taxable property on the County's official tax rolls, not on the property's market value. Property owners should consult their own property tax bills to determine their property's assessed value and any applicable tax exemptions.

IMPARTIAL ANALYSIS OF MEASURE “A”

The Board of Education (“Board”) of the Desert Sands Unified School District (“District”) by adopting Resolution No. 12/2023-2024 (“Resolution”), elected to call an election pursuant to Section 18 of Article XVI and Section 1 of Article XIII A of the California Constitution and Section 15100 and 15264 *et seq.* of the California Education Code to obtain authorization to issue and sell general obligation Bonds (“Bonds”) in the aggregate amount principal amount of six hundred seventy-five million dollars (\$675,000,000).

This Measure was placed on the ballot by the Board of the District.

The Bonds would be used by the District to upgrade classrooms, science labs, career-training facilities, and instructional technology to support college/career readiness in math, science, technology, engineering, arts/skilled trades; safeguard student safety; fix deteriorating roofs, plumbing, electrical, ventilation systems; repair, construct, acquire classrooms, facilities, and sites/equipment. The Bonds would not be used to fund the salaries, pensions or benefits of any board members, administrator, and/or teachers or for other school operating expenses.

If Measure A is approved, the Board of the District will appoint a citizens’ oversight committee, and conduct annual independent financial and performance audits to ensure that bond funds are spent only on the construction, modernization, rehabilitation, or replacement of school facilities, furnishings and/or equipment, or the acquisition or lease of property for school facilities, and for no other purposes.

An ad valorem tax would be levied and collected on property within the boundaries of the District to pay the principal and interest on the Bonds. The best estimate of the average annual tax rate at this time is \$0.049 per \$100 per assessment (or \$49 per \$100,000) of assessed value.

The Resolution provides that the maximum interest rate on the Bonds will not exceed the maximum statutory interest and the maximum term of the Bonds, or any series thereof, will not exceed the maximum statutory term. The best estimate of the total debt service, including the principal and interest, that would be required to be repaid if all of the bonds are issued and sold is \$1,371,994,476.

For this Measure to be approved fifty-five percent (55%) of qualified voters who vote on the Measure must vote yes.

A “YES” vote on Measure “A” is a vote to allow the District to sell the Bonds and levy the necessary taxes to pay for the Bonds.

A “NO” vote on Measure “A” is a vote against allowing the District to sell the Bonds and levy the necessary taxes to pay for the Bonds.

Same Day Voter Registration

4. Once the Registrar of Voters processes your registration, and determines you are eligible, you will be registered to vote and your ballot will be counted.

California Motor Voter

The California Motor Voter program is making registering to vote at the California Department of Motor Vehicles (DMV) more convenient and secure. All eligible individuals completing driver's license or ID card or change of address transactions at the DMV will be registered to vote with the California Secretary of State unless they "opt out" of automatic voter registration.

The California Motor Voter program applies to Californians who are 18 years or older and meet the following criteria:

- A United States citizen and a resident of California.
- Not currently serving in a state or federal prison for the conviction of a felony.
- Not currently found mentally incompetent to vote by a court.

Note: Voter pre-registration is available for those 16 and 17 years of age. Their voter registration will become active automatically when they turn 18.



Before visiting a DMV field office, we recommend making an appointment.

Visit <https://www.dmv.ca.gov/portal/dmv/detail/portal/foa/welcome> to get started. You can also use DMV online services (<https://www.dmv.ca.gov/portal/dmv/dmv/online/vcs>) to renew your driver's license or ID card or change your address.

If you indicate you're eligible to vote, once you complete your driver's license or state ID renewal form transaction online, by mail or in person at the DMV, your voter information is then transmitted securely and electronically to the California Secretary of State.

Please note that drivers with an AB 60 driver's license are not eligible to participate in the California Motor Voter program and are not eligible to vote.

Remote Accessible Vote-by-Mail

The Remote Accessible Vote-by-Mail (RAVBM) system delivers ballots to voters electronically. RAVBM is not “internet voting!” The system was created as a tool to allow voters with disabilities who prefer or need to vote from home, the option to read and mark their ballot with more privacy and independence. Under Assembly Bill 37 (2021), any active registered voter may now use the RAVBM system. To ensure the privacy of each voter’s selections, the RAVBM system does not store the voter’s choices or transmit them over the internet.

RAVBM lets you:

- Download, mark, and print your ballot at home
- Use your own assistive technology to read and mark the ballot

How Can I Vote Using the RAVBM System?

1. Request an RAVBM ballot Access Link

Contact the elections office by phone at (951) 486-7200 or (800) 773-VOTE (8683), by email at rovweb@rivco.org, or on the web at www.voteinfo.net. Log into the RAVBM system by entering your personal information to verify your eligibility.

2. Mark your ballot

Use the link to access and open your ballot and instructions. Review and mark the ballot on your own computer, with your own assistive technology, if needed.

3. Review and print your ballot

Check your ballot and make corrections, if needed. Download and print your ballot.

4. Seal and sign the ballot envelope

Put your RAVBM ballot in the envelope you received in the mail. Sign the voter’s declaration (punched holes tell you where to sign). Seal the envelope. You must sign this envelope for your ballot to be counted. If you cannot sign your name, you may make a mark on the signature line and have someone else write your name and sign the envelope as a witness.

If you do not have your county-issued ballot return envelope, follow the instructions in the return package. RAVBM ballots cannot be returned by email or fax.

5. Return your ballot

VOTER BILL OF RIGHTS

YOU HAVE THE FOLLOWING RIGHTS:

- ★ 1 The right to vote if you are a registered voter.**
You are eligible to vote if you are:
 - a U.S. citizen living in California
 - at least 18 years old
 - registered where you currently live
 - not currently serving a state or federal prison term for the conviction of a felony
 - not currently found mentally incompetent to vote by a court
- ★ 2 The right to vote if you are a registered voter even if your name is not on the list.** You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.
- ★ 3 The right to vote if you are still in line when the polls close.**
- ★ 4 The right to cast a secret ballot** without anyone bothering you or telling you how to vote.
- ★ 5 The right to get a new ballot if you have made a mistake,** if you have not already cast your ballot. You can:
 - Ask an elections official at a polling place** for a new ballot,
 - Exchange your vote-by-mail ballot** for a new one at an elections office, or
 - at your polling place, or**
 - Vote using a provisional ballot.**
- ★ 6 The right to get help casting your ballot** from anyone you choose, except from your employer or union representative.
- ★ 7 The right to drop off your completed vote-by-mail ballot at any polling place** in California.
- ★ 8 The right to get election materials in a language other than English** if enough people in your voting precinct speak that language.
- ★ 9 The right to ask questions to elections officials about election procedures** and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- ★ 10 The right to report any illegal or fraudulent election activity** to an elections official or the Secretary of State's office.

Tips for California's Military and Overseas Voters

Taking part in elections is more convenient than ever for Californians serving in the military or living outside the United States. It begins when you register to vote as a military or overseas voter and receive election materials by mail, fax, or email.

- **Start early.** California's county elections officials begin sending ballots to military and overseas voters 60 days before Election Day. Fill out a voter registration application early at RegisterToVote.ca.gov to ensure that you receive your voting materials in time.
- **Know your options.** When registering to vote as a military or overseas voter, you can choose to have your ballot mailed, faxed, or emailed to you. You may return your voted ballot to your county elections official by mail or, in certain circumstances, by fax. If you meet the requirements to return your ballot by fax, you must also fax the Oath of Voter form (available from your county elections official) waiving your right to a confidential ballot.
- **Stay in touch.** Once you register as a military or overseas voter, you will continue to receive a ballot and election materials from your county elections official before each election. We encourage you to update your registration each year, if needed; however, you must re-register to vote if you change your address, your name, or your political party preference, or if you do not participate in four consecutive statewide general elections. Visit www.sos.ca.gov/elections/voter-registration/military-overseas-voters/ for more election resources designed especially for you.

Dates to remember:

February 20: last day to register to vote and request your ballot

February 27: last day to update or change how you want to receive your ballot

March 5: Election Day. Mailed ballots must be postmarked on or before Election Day and received by your county elections office no later than March 12.

Faxed ballots must be delivered to your county elections office by close of polls, no later than 8:00 p.m. Pacific Standard Time, on Election Day.

ACCOMMODATIONS FOR VOTERS WITH DISABILITIES

All Vote Centers are accessible to voters who are physically disabled. Please be advised of the following alternate ways you may cast your ballot.

- **By Mail** - Your ballot must be received at the Registrar of Voters office no later than 8:00 p.m. on Election Day or be postmarked on or before Election Day and received no later than seven days after Election Day to be counted. You may request a Vote-by-Mail ballot for all future Elections. Simply contact the Registrar of Voters office by calling (951) 486-7200, (800) 773-VOTE (8683), California Relay Service (Dial 711).
- **Early Voting** - You may vote at the Registrar of Voters office February 5 - March 4, Monday through Friday, 8:00 a.m. to 5:00 p.m.; February 24 - February 25, 9:00 a.m. to 5:00 p.m., and March 2 - March 3, 9:00 a.m. to 5:00 p.m.; and Election Day, March 5, 7:00 a.m. to 8:00 p.m. Please visit our website at www.voteinfo.net for additional early voting locations and information.
- **Remote Accessible Vote by Mail Ballot (RAVBM)** - Accessible Vote-by-Mail provides an accessible option for voters to mark their ballots privately and independently. To complete a RAVBM ballot visit www.voteinfo.net. Your completed ballot and signed Oath of the Voter must be returned to the Registrar of Voters office no later than 8:00 p.m. on Election Day or be postmarked on or before Election Day and received no later than seven days after Election Day to be counted.
- **Curbside Voting on Election Day** - If you are unable to enter the location due to a physical disability, you may request Curbside Voting at any Vote Center. Curbside Voting doorbells and signs are available at all Vote Centers. If you require Curbside Voting assistance you may call (877) 663-9906 before going to a Vote Center and/or when you arrive at the facility. An Election Officer will be contacted prior to your arrival to meet you at the curb.
- **Large Print State Voter Information Guide** - If you prefer a large print State Voter Information Guide, you may request one by contacting the California Secretary of State's office at (800) 345-VOTE (8683), or by contacting the Registrar of Voters office at (951) 486-7200, (800) 773-VOTE (8683), California Relay Service (Dial 711).
- **Disability Rights California** will operate a statewide hotline on March 5, Election Day, from 7:00 a.m. to 8:00 p.m. The phone number is (888) 569-7955.
