Dear County of Riverside Voter,

Election Day for the Statewide Direct Primary Election is just around the corner on June 2, 2026! Your County Voter Information Guide is here, providing essential details for voting, including instructions on marking your ballot, candidate information, a sample ballot, and other important election details to review before you vote. Tip: You can mark your sample ballot and bring it with you to any Vote Center for easy reference.

Starting May 4, 2026, ballots will be mailed to all active registered voters in the County of Riverside. You can check your registration at [voterstatus.sos.ca.gov](https://voterstatus.sos.ca.gov) or register at [registertovote.ca.gov](https://registertovote.ca.gov).

Vote at any Vote Center. We have more days and more ways to cast your ballot!

- **Returning Your Ballot:** You may drop off your ballot at any secure ballot Drop-Off location starting May 4, 2026, or mail your ballot via USPS (no postage needed).
- **Receiving Your Ballot:** Your ballot must be received by the Registrar of Voters by Election Day or postmarked on Election Day and received within seven days (June 9, 2026).
- **Tracking Your Ballot:** Register at [WheresMyBallot.sos.ca.gov](https://WheresMyBallot.sos.ca.gov).

**Early Voting:** Vote in person at the Registrar of Voters office starting May 4, 2026, 8:00 a.m. to 5:00 p.m. Hours change on May 23 - 24, and May 30 - 31 to 9:00 a.m. to 5:00 p.m. For a list of locations and hours, visit [voteinfo.net](https://voteinfo.net).

**Election Day:** All Vote Centers, including the Registrar of Voters office, will be open from 7:00 a.m. to 8:00 p.m.

# Elections in California

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Previously known as partisan offices, voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still must be held.

California's open primary system does not apply to candidates running for U.S. President, county central committee, or local offices.

Write-in candidates for voter-nominated offices may still run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election. Additionally, there is no independent nomination process for a general election.

California law requires the following information to be printed in this guide.

## Voter-Nominated Offices

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election. A candidate for nomination to a voter-nominated office shall have his or her qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party. In the county voter information guide, parties may list the candidates for voter-nominated offices who have received the party's official endorsement.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation move on to the general election, unless the candidate is one of the two highest vote-getters at the primary election.

## Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election. A candidate for nomination to a nonpartisan office may not designate his or her party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

## IMPARTIAL ANALYSIS OF MEASURE "Z"

Measure Z was placed on the ballot by the Riverside City Council. If approved, it would amend the City of Riverside's existing Transaction and Use (Sales) Tax by revising Chapter 3.08 of the Riverside Municipal Code.

In 2016, City of Riverside voters approved the existing Transaction and Use (Sales) Tax, also named "Measure Z", which expires on March 30, 2036. Voter approval of this Measure Z will eliminate this expiration, and it would remain in effect until ended by the voters.

This Measure Z would also increase the existing 1% Transaction and Use (Sales) Tax rate. If approved by voters, Measure Z would increase the rate by .25%, to a total of 1.25%. The City of Riverside estimates Measure Z, if approved, would generate approximately an additional \$21 Million annually in sales tax revenue. The estimated total annual Transaction and Use (Sales) Tax revenue would then be approximately \$106 Million.

"Transaction and use taxes" like Measure Z are commonly known as "sales taxes." With some exceptions, these taxes are levied on the sale or use of tangible personal property sold at retail. Retailers collect the tax at the time of sale and remit the funds to the California Department of Tax and Fee Administration, which transmits the revenue back to the City of Riverside.

Currently, the total retail sales tax in Riverside City is 8.75% of the purchase price, which is calculated as 8  $\frac{3}{4}$  cents per dollar spent. The revenue from this tax is allocated to the State, Riverside County, and the City of Riverside. Of the 8.75%, 7.25% is the Statewide base rate, the County of Riverside receives .50%, and the City of Riverside receives 1%. If Measure Z passes, the total retail sales tax in the City of Riverside will be 9%, or 9 cents for every dollar spent.

Measure Z is a "general" tax, meaning the City of Riverside may use the revenues for any governmental purpose (the ballot measure provided the following examples: fire safety and emergency response needs, police response, street and pothole repairs, and other general city services). Revenue from the tax increase proposed in Measure Z would go only to the City of Riverside, to be placed in the general fund. A majority vote (50% + 1) is needed for Measure Z to pass.

If Measure Z is not approved, the existing City sales tax would remain unchanged at the existing rate of 1% and expire March 1, 2036.

A "yes" vote is a vote in favor of authorizing the extension and rate increase for the Transaction and Use (Sales) Tax.

A "no" vote is a vote against authorizing the extension and rate increase for the Transaction and Use (Sales) Tax.

**REBUTTAL TO ARGUMENT IN FAVOR OF MEASURE "Z"**

Riverside voters have seen this playbook before. Every few years, the same warning arrives: vote YES or lose 911, fire, and paramedics. The sky is always falling despite City revenues outpacing inflation.

Nothing is expiring. Measure Z runs until 2036 - a full decade away. Calling this a "renewal" ten years early is manufactured urgency designed to prevent scrutiny of what's actually being asked: make the tax permanent and raise it immediately by ¼ cent.

If you read the actual ordinance behind the measure, there's no mention of required audits and spending disclosure. Promises made in the non-binding argument are not worth the paper it's written on.

The same City Council claiming to fund wildfire prevention voted in 2024 to run the Riverside Transmission Reliability Project's high-voltage lines above ground through a fire-prone Santa Ana River corridor, over the objections of neighboring communities and fire safety experts. They could have buried those lines. Talk is cheap. Actions reveal priorities.

Notice who signed. The Riverside City Firefighters Association received automatic raises tied directly to 2016 Measure Z revenue. They are not neutral public servants. They are beneficiaries urging you to make the money permanent and increase it.

In November 2024, Riverside voters approved an Inspector General to find fraud, waste, and abuse in City government. That position remains unfilled. Rather than letting that watchdog identify savings first, the City asks for more money. That is the easy way out ... and you are paying for it.

**ARGUMENT AGAINST MEASURE "Z"**

Riverside voters have heard these promises before. Many times.

2010, hotel taxes from Measure V were to pay for 911, fire, police, youth programs

2013, Measure A (water tax): police, fire, after-school, senior services.

2016, Measure Z (sales tax): police, fire, paramedics, homelessness, street repairs.

2021, Measure C (electricity tax): police, fire, paramedics, street repairs, homelessness.

2026, this measure (another sales tax): police, fire, homelessness, potholes.

Five measures. Sixteen years. Almost the exact same list every time. So where is the money going?

Not to what they promise. Each measure was structured as a general tax, meaning the City had no legal obligation to spend a single dollar as advertised. Measure Z funds paid pension obligation bonds and automatic employee raises never mentioned to voters. The ballot language was bait. The general tax structure was the switch.

Who is making the argument for this measure? Many of the same people backed by the same organizations. They will fund the mailers urging you to vote 'yes' yet again. They stand to benefit while making Riverside a little less affordable for the rest of us.

When voters approved Measure Z in 2016, it was projected to generate \$48 million annually. It now hauls in \$85 million because Riverside has grown and prospered. If police, fire, and vital services were truly the priority, they would already be fully funded.

Nothing is even expiring. Measure Z doesn't sunset until 2036 - a full decade from now. This "renewal" is a .25% rate increase on a tax that isn't ending, sold with promises the City has broken repeatedly.

If the City genuinely wants to fund police, fire, and vital services, bring voters a special tax legally restricted to those purposes. Five measures, sixteen years, same promises, same bait-and-switch.

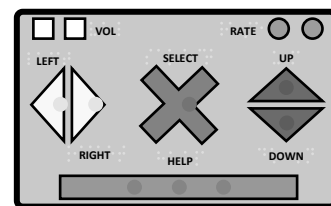

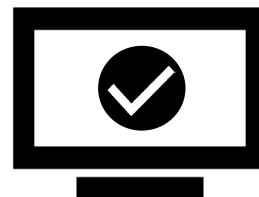


## Remote Accessible Vote by Mail (RAVBM)

# California Voter ID & Registration Requirements

## Who Can Register to Vote in California?

To register, you must be:

- A United States citizen and a California resident
- 18 years or older on Election Day (or 16 or 17 years old to pre-register)
- Not currently serving a state or federal prison term for a felony
- Not currently found mentally incompetent to vote by a court

## Do I Need to Show ID to Vote in California?

In most cases, NO. California does not generally require voters to show identification at the polls.

## When MIGHT You Be Asked for ID?

You may need to show ID only if ALL the following apply:

- You're voting for the first time in a federal election
- You registered by mail or online, AND
- You did not provide your CA ID or SSN when registering

You'll be notified in advance if this applies to you.

**Poll workers may only request an ID if the voter list clearly indicates it's required.**

## What Forms of ID Are Acceptable (if required)?

You can show a photo or non-photo ID, including:

- California Driver's License or State ID card
- U.S. Passport
- Student or Military ID
- Official mail from a government agency
- Paycheck or government check
- Utility bill or bank statement

Photo ID is not required, it's just one of many valid options. ID does not need to show your address or be government-issued.

## Don't Have ID When Voting?

You can still cast a provisional ballot. Your ballot will be counted after elections officials have confirmed you are registered to vote in that county, and you did not already vote in that election.

## Check Your Voter Status Online

Visit the Secretary of State's My Voter Status page at [voterstatus.sos.ca.gov](http://voterstatus.sos.ca.gov) to check your voter status, find your polling place or a vote center, and much more.

To check your voter status, you will need to enter your first name, last name, date of birth, and your California driver's license or California identification card number, or the last four digits of your social security number.

# How to Fix a Missing or Noncomparable Signature on Your Vote-by-Mail Ballot Return Envelope

## ✓ Possible Issues With Vote-by-Mail or Provisional Ballot Return Envelopes

- **Missing Signature:** You forgot to sign your vote-by-mail ballot return envelope.
- **Signature Doesn't Compare:** Your signature doesn't compare with the one on file with the elections official.

## ✓ What Happens Next?

- **Notification:** If there's an issue with your ballot, your county elections office will notify you by mail, phone, email, or from the Secretary of State's *Where's My Ballot?* tool.
- **How to Fix It:** You can access a form on your county elections official's website to provide your signature and confirm that you voted your ballot.
  - Check your mail or email for instructions from your county elections office
  - Fill out the form and follow instructions on how to return the form
  - Your options to return the form may vary by county
  - Failure to follow instructions may result in your ballot not being counted

## ✓ Stay Informed With *Where's My Ballot?*

- **Track Your Vote-by-Mail Ballot:** Get automatic updates on your ballot's status by signing up for *Where's My Ballot?*
- Receive notifications via **text, email, or phone** about:

## ✓ Important Deadlines for the June 2, 2026, Statewide Direct Primary Election:

- **Mail ballots:** Return your ballot by mail as soon as you receive it. Must be postmarked no later than June 2, 2026, and received no later than June 9, 2026.
- **Deadline:** The deadline to fix your missing or noncomparable signature is 5:00 p.m. on June 24, 2026.

# VOTER BILL OF RIGHTS

---

## YOU HAVE THE FOLLOWING RIGHTS:

- 1** **The right to vote if you are a registered voter.** You are eligible to vote if you are:
  - a U.S. citizen living in California
  - at least 18 years old
  - registered where you currently live
  - not currently serving a state or federal prison term for the conviction of a felony
  - not currently found mentally incompetent to vote by a court
- 2** **The right to vote if you are a registered voter even if your name is not on the list.** You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.
- 3** **The right to vote if you are still in line when the polls close.**
- 4** **The right to cast a secret ballot** without anyone bothering you or telling you how to vote.
- 5** **The right to get a new ballot if you have made a mistake,** if you have not already cast your ballot. You can:
  - Ask an elections official at a polling place** for a new ballot,
  - Exchange your vote-by-mail ballot** for a new one at an elections office, or at your polling place, or
  - Vote using a provisional ballot.**
- 6** **The right to get help casting your ballot** from anyone you choose, except from your employer or union representative.
- 7** **The right to drop off your completed vote-by-mail ballot at any polling place** in California.
- 8** **The right to get election materials in a language other than English** if enough people in your voting precinct speak that language.
- 9** **The right to ask questions to elections officials about election procedures** and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- 10** **The right to report any illegal or fraudulent election activity** to an elections official or the Secretary of State's office.

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT.

## WHERE:

- Within the immediate vicinity of a person in line to cast their ballot or within 100 feet of the entrance of a polling place, curbside voting or drop box the following activities are prohibited.

## WHAT ACTIVITIES ARE PROHIBITED:

- **DO NOT** ask a person to vote for or against any candidate or ballot measure.
- **DO NOT** display a candidate's name, image, or logo.
- **DO NOT** block access to or loiter near any ballot drop boxes.
- **DO NOT** provide any material or audible information for or against any candidate or ballot measure near any polling place, vote center, or ballot drop box.
- **DO NOT** circulate any petitions, including for initiatives, referenda, recall, or candidate nominations.
- **DO NOT** distribute, display, or wear any clothing (hats, shirts, signs, buttons, stickers) that include a candidate's name, image, logo, and/or support or oppose any candidate or ballot measure.
- **DO NOT** display information or speak to a voter about the voter's eligibility to vote.

The electioneering prohibitions summarized above are set forth in Article 7 of Chapter 4 of Division 18 of the California Elections Code.

- **Remote Accessible Vote by Mail Ballot (RAVBM)** - Accessible Vote-by-Mail provides an accessible option for voters to mark their ballots privately and independently.
