Please note – this year voting is different! This Voter Information Guide contains information for the November 3, 2020 Consolidated General Election. In an effort to reduce the spread of COVID-19 and in accordance with State Law, the Riverside County Registrar of Voters will be deploying a new election model for the upcoming November 3, 2020 Election. This will offer our voters more ways and more days to vote safely. Each eligible registered voter for the November 3, 2020 Election will receive a ballot by mail beginning Monday, October 5, 2020 in accordance with the Governor's Executive Order.

Voters can verify their voter registration at <u>voterstatus.sos.ca.gov</u> or register to vote at registertovote.ca.gov.

- Your Vote-By-Mail ballot may be returned at any of our 80 secure Ballot Drop-Off locations that will be available beginning October 5, 2020 or via USPS (no postage required).
- We are now operating nearly 130 Voter Assistance Centers throughout Riverside County. You can vote in-person at any location from October 31 – November 3, 2020.
- You may track your ballot by registering at <u>WheresMyBallot.sos.ca.gov</u>.
- A list of all Ballot Drop-Off locations and Voter Assistance Centers is posted at www.voteinfo.net.

The Riverside County Registrar of Voters recommends that voters only use the in-person Voter Assistance Centers if absolutely necessary, as the generalized use of in-person voting presents risks to public health and safety in light of the COVID-19 pandemic. Social distancing will be required when visiting a Voter Assistance Center and face coverings are strongly encouraged.

Elections in California

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Previously known as partisan offices, voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent +1), a general election still must be held.

California's open primary system does not apply to candidates running for U.S. President, county central committees, or local offices.

Write-in candidates for voter-nominated offices can still run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election. Additionally, there is no independent nomination process for a general election.

California law requires the following information to be printed in this guide.

Party-Nominated/Partisan Offices

Political parties may formally nominate candidates for party-nominated/partisan offices at the primary election. A nominated candidate will represent that party as its official candidate for the specific office at the general election and the ballot will reflect an official designation. The top vote-getter for each party at the primary election moves on to the general election. Parties also elect officers of county central committees at the primary election.

A voter can only vote in the primary election of the political party he or she has disclosed a preference for upon registering to vote. However, a political party may allow a person who has declined to disclose a party preference to vote in that party's primary election.

Voter-Nominated Offices

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election. A candidate for nomination to a voter-nominated office shall have his or her qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party. In the county voter information guide, parties may list the candidates for voter-nominated offices who have received the party's official endorsement.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation move on to the general election, unless the candidate is one of the two highest vote-getters at the primary election.

Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election. A candidate for nomination to a nonpartisan office may not designate his or her party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.



IMPARTIAL ANALYSIS OF MEASURE "U"

In 2018, the voters of Jurupa Valley approved a ballot measure allowing cannabis businesses in certain zones in the City and imposing a City tax on cannabis businesses.

Measure U would repeal the existing cannabis business ordinance and impose regulatory and operational requirements, amend the zoning regulations, and increase the City tax on cannabis businesses.

- All cannabis businesses shall obtain both a conditional use permit and an annual regulatory permit.
- Cannabis retailers would be conditionally permitted uses in the C-1/C-P (General Commercial) and R-VC (Rubidoux-Village Commercial) zones. The Council could allow retailers to locate in additional zones and to establish "retail cannabis areas" so as to prevent over-concentration in any one area.
- One cannabis retailer would be allowed per 12,000 population, which
 means nine would be allowed under the City's current population.
- If there are more qualified applicants than available permits, a lottery would be held to determine which cannabis retailers could apply for a permit.
- Cannabis businesses could not obtain a conditional use permit if located within 1,000 feet of the following uses: (1) school providing instruction in kindergarten or any grades 1 through 12; (2) day care center; (3) youth center; (4) church or religious facility; or (5) park.
- The parking requirements for a cannabis retailer would be increased to three (3) parking spaces for every 200 square feet of retail area or such additional spaces as may be required by a required parking study.
- Operational standards would be imposed related to security, community relations, odor control, signage, hours of operation, and cannabis consumption, as well as conduct background checks on employees, owners and persons with a financial interest in the cannabis business.
- Existing cannabis businesses with a State license to operate in the City, would be exempt from obtaining a conditional use permit but would have three months from the effective date to obtain a regulatory permit, and nine months to come into compliance with any applicable operational standards.

Facilities for indoor Cannabis cultivation, distribution, manufacturing, microbusinesses, and testing laboratories would be conditionally permitted uses in the M-SC (Manufacturing Service Commercial) and BP (Business Park) zones. The Council is authorized to add zones where these businesses could operate.

Measure U would increase City tax on cannabis businesses by imposing an annual gross receipts tax in the following percentages: retailers (6%), distributors (2%), manufacturing (2.5%), testing laboratories (1%). Indoor cultivation would be taxed at \$10 per square foot of cultivation area. These are general taxes that can be used for general municipal purposes, such as public safety, road repairs, youth programs, and parks. Measure U requires a simple majority vote to pass. The amount of revenue generated by these taxes is dependent on the size and number of cannabis businesses that operate each year and is estimated to generate approximately \$1,681,383 per year in new taxes for the City until repealed by the voters.

Measure U was placed on the ballot by the Jurupa Valley City Council.

- Require annual cannabis permits following a public hearing to enable the City to monitor dispensaries and other cannabis businesses on an on-going basis and address potential problems;
- A more equitable means of licensing cannabis dispensaries and cannabis businesses without artificial limits on who can operate a cannabis business; and
- No concentration of cannabis dispensaries in one particular commercial area.

The people of Jurupa Valley deserve an up-to-date and fair regulations of cannabis businesses and an appropriate tax on cannabis businesses.

Additionally, remember that if you need assistance you may bring up to two people to assist you in voting, as long as they are not representatives from your employer or your union (if you have one).

You may also request a translated sample ballot to be sent to you by completing the request form on the back cover of this Guide, by calling (800) 733-VOTE (8683), or by visiting www.voteinfo.net. Requests must be received no later than 7 days before the election.

Conditional Voter Registration

Did you forget to register or update your voter registration? No Problem! A new law allows you to register to vote and vote until 8:00 p.m. on Election Day at your county elections office or at any voter assistance center in your county. This process is called Conditional Voter Registration (CVR) and is commonly referred to as Same Day Voter Registration. Here's how it works:

- 1. Visit the Registrar of Voters office or any Voter Assistance Center.
- 2. Complete a voter registration card or register online at RegisterToVote.ca.gov.
- 3. Vote your ballot.
- 4. Once the county elections official processes your registration and determines you are eligible, you will be registered to vote and your ballot will be counted.

California Motor Voter

The California Motor Voter program is making registering to vote at the California Department of Motor Vehicles (DMV) more convenient and secure. All eligible individuals completing driver license or ID card or change of address transactions at the DMV will be registered to vote with the California Secretary of State unless they "opt out" of automatic voter registration.

The California Motor Voter program applies to Californians who are 18 years or older and meet the following criteria:

- A United States citizen and a resident of California.
- Not currently in state or federal prison or on parole for the conviction of a felony.
- Not currently found mentally incompetent to vote by a court.

Note: Voter pre-registration is available for those 16 and 17 years of age. Their voter registration will become active automatically when they turn 18.

Before visiting a DMV field office, we recommend making an appointment. Visit https://www.dmv.ca.gov/portal/dmv/detail/portal/foa/welcome to get started. You can also use DMV online services (https://www.dmv.ca.gov/portal/dmv/dmv/onlinesvcs) to renew your driver license or ID card or change your address.

If you indicate you're eligible to vote, once you complete your driver license or state ID renewal form transaction online, by mail or in person at the DMV, your voter information is then transmitted securely and electronically to the California Secretary of State.

Please note that drivers with an AB 60 driver's license are not eligible to participate in the California Motor Voter program and are not eligible to vote.

Remote Accessible Vote-by-Mail (RAVBM) in Riverside County

For the November 3, 2020 General Election, all voters will receive a ballot in the mail. Riverside County will begin mailing voters their ballots on October 5th.

You can also vote with Remote Accessible Vote-by-Mail. RAVBM lets you:

- Download, mark, and print your ballot at home
- Use your own assistive technology to read and mark the ballot
- Select the language for your ballot

RAVBM is not "internet voting." You must print and return your marked ballot.



You must request your RAVBM ballot by October 27th

How to vote from home (accessibly!) with RAVBM:

1. Request an RAVBM ballot access link

Contact the elections office by phone at (951) 486-7200 or (800) 773-VOTE (8683), by email at rovweb@rivco.org, or on the web at www.voteinfo.net.

2. Mark your ballot

Use the access link to open your ballot. Review and mark the ballot on your own computer, with your own assistive technology if needed.

3. Review and print your ballot

Check your ballot and make corrections. Download and print your ballot.

4. Seal and sign the ballot envelope

Put your RAVBM ballot in the envelope you received in the mail. Sign the voter's declaration (punched holes tell you where to sign). Seal the envelope.

5. Return your ballot

By mail. (Your envelope will include pre-paid postage!)

At any drop box in Riverside County.

At any voting location or at the Riverside County elections office.

RIGHTS

YOU HAVE THE FOLLOWING RIGHTS:



The right to vote if you are a registered voter. You are eligible to vote if you are:

- a U.S. citizen living in California
- at least 18 years old
- registered where you currently live
- not currently in state or federal prison or on parole for the conviction of a felony
- not currently found mentally incompetent to vote by a court



The right to vote if you are a registered voter even if your name is not on the list. You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.



The right to vote if you are still in line when the polls close.



The right to cast a secret ballot without anyone bothering you or telling you how to vote.



The right to get a new ballot if you have made a mistake, if you have not already cast your ballot. You can:

Ask an elections official at a polling place for a new ballot.

Exchange your vote-by-mail ballot for a new one at an elections office or at your polling place, or

Vote using a provisional ballot.



The right to get help casting your ballot from anyone you choose, except from your

employer or union representative.



The right to drop off your completed vote-by-mail ballot at any polling place in California.



The right to get election materials in a language other than English if enough people in your voting precinct speak that language.



The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.



The right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's office.

- By Mail Your ballot must be received at the Registrar of Voters office no later than 8:00 p.m. on Election Day
 or be postmarked on or before Election Day and received no later than seventeen days after Election Day
 to be counted. You may request a Vote-by-Mail ballot for all future Elections. Simply contact the Registrar of
 Voters office by calling (951) 486-7200, (800) 773-VOTE (8683), TTY (951) 697-8966.
- Early Voting You may vote at the Registrar of Voters office located at 2720 Gateway Drive, Riverside, CA 92507, October 5 October 30 (excluding Holidays), Monday through Friday, 8:00 a.m. to 5:00 p.m.; Saturday, October 24, 9:00 a.m. to 4:00 p.m. The Registrar of Voters office will also be open for the 3 days prior to Election Day, Saturday, October 31 through Monday, November 2, from 9:00 a.m. to 5:00 p.m.; and Election Day, November 3, 7:00 a.m. to 8:00 p.m. Please visit our website at www.voteinfo.net for additional early voting locations and information.
- Curbside Voting on Election Day If you are unable to enter the location due to a physical disability, you may request Curbside Voting at any voter assistance center. An Election Officer will be contacted prior to your arrival to meet you at the curb.
