Please note – this year voting is different! This Voter Information Guide contains information for the November 3, 2020 Consolidated General Election. In an effort to reduce the spread of COVID-19 and in accordance with State Law, the Riverside County Registrar of Voters will be deploying a new election model for the upcoming November 3, 2020 Election. This will offer our voters more ways and more days to vote safely. Each eligible registered voter for the November 3, 2020 Election will receive a ballot by mail beginning Monday, October 5, 2020 in accordance with the Governor's Executive Order.

Voters can verify their voter registration at <u>voterstatus.sos.ca.gov</u> or register to vote at registertovote.ca.gov.

- Your Vote-By-Mail ballot may be returned at any of our 80 secure Ballot Drop-Off locations that will be available beginning October 5, 2020 or via USPS (no postage required).
- We are now operating nearly 130 Voter Assistance Centers throughout Riverside County. You can vote in-person at any location from October 31 November 3, 2020.
- You may track your ballot by registering at <u>WheresMyBallot.sos.ca.gov</u>.
- A list of all Ballot Drop-Off locations and Voter Assistance Centers is posted at www.voteinfo.net.

The Riverside County Registrar of Voters recommends that voters only use the in-person Voter Assistance Centers if absolutely necessary, as the generalized use of in-person voting presents risks to public health and safety in light of the COVID-19 pandemic. Social distancing will be required when visiting a Voter Assistance Center and face coverings are strongly encouraged.

Elections in California

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Previously known as partisan offices, voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent +1), a general election still must be held.

California's open primary system does not apply to candidates running for U.S. President, county central committees, or local offices.

Write-in candidates for voter-nominated offices can still run in the primary election. However, a write-in candidate can only move on to the general election if the candidate is one of the top two vote-getters in the primary election. Additionally, there is no independent nomination process for a general election.

California law requires the following information to be printed in this guide.

Party-Nominated/Partisan Offices

Political parties may formally nominate candidates for party-nominated/partisan offices at the primary election. A nominated candidate will represent that party as its official candidate for the specific office at the general election and the ballot will reflect an official designation. The top vote-getter for each party at the primary election moves on to the general election. Parties also elect officers of county central committees at the primary election.

A voter can only vote in the primary election of the political party he or she has disclosed a preference for upon registering to vote. However, a political party may allow a person who has declined to disclose a party preference to vote in that party's primary election.

Voter-Nominated Offices

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election. A candidate for nomination to a voter-nominated office shall have his or her qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party. In the county voter information guide, parties may list the candidates for voter-nominated offices who have received the party's official endorsement.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office even if both candidates have specified the same party preference designation. No party is entitled to have a candidate with its party preference designation move on to the general election, unless the candidate is one of the two highest vote-getters at the primary election.

Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election. A candidate for nomination to a nonpartisan office may not designate his or her party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.



MEASURE "L" - CITY OF BANNING

ORDINANCE NO. ____

AN ORDINANCE OF THE PEOPLE OF THE CITY OF BANNING, CALIFORNIA AMENDING CHAPTER 3.17 (CANNABIS COMMERCIAL CULTIVATION, MANUFACTURING, AND LABORATORY TESTING TAX) OF TITLE 3 (REVENUE AND FINANCE) OF THE BANNING MUNICIPAL CODE TO ADD PROVISIONS ESTABLISHING A GENERAL PURPOSE TAX ON CANNABIS DISTRIBUTION FACILITIES

THE PEOPLE OF THE CITY OF BANNING DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Recitals.

- A. On November 6, 2018, the Banning voters adopted Measure N imposing a tax on cannabis cultivation, manufacturing and testing laboratory facilities. Measure N, which is codified in Banning Municipal Code ("BMC") Chapter 3.17, sets the cannabis cultivation tax rate at \$15 per square foot of canopy space and sets a 10% gross receipts tax on cannabis manufacturing and testing laboratory facilities. The Banning voters also adopted Measure O imposing a tax on cannabis retailers in the amount of 10% of the business' gross receipts.
- B. On July 10, 2018, the City Council adopted Ordinance 1524, which added Chapter 5.35 to the Banning Municipal Code, to establish procedures allowing for the issuance of cannabis regulatory permits to cannabis cultivation, manufacturing, and testing laboratory facilities to operate in the Industrial Zone. The City Council also adopted Ordinance 1523, which added Chapter 17.53 to the Banning Municipal Code, to establish zoning regulations and procedures for the issuance of cannabis conditional use permits. The ordinances contained provisions stating that they would only go into effect if the voters adopted Measure N.
- C. On November 13, 2018, the City Council adopted Ordinance 1527 (later renumbered as Ordinance 1523), which added Chapter 5.33 to the Banning Municipal Code, to establish procedures allowing for the issuance of cannabis regulatory permits to cannabis retailers to allow them to operate in the Highway Serving Commercial zone. The City Council also adopted Ordinance 1531, which added Chapter 17.54 to the Banning Municipal Code, to establish zoning regulations and procedures for the issuance of cannabis conditional use permits to cannabis retailers.
- D. The City Council has determined that cannabis distributors are an integral part of the cannabis supply chain. Cannabis cultivators are required to use licensed distributors to transport their harvested cannabis products from the cultivation location to manufacturers and testing laboratories. The distributors collect the state's cultivator tax from cultivators as part of this process. In addition, all cannabis and cannabis products, whether from a cultivator or manufacturer, must be tested in laboratories, which again, must be transported to those laboratories by state licensed distributors. Finally, once the cannabis product has been tested and packaged, it is only state licensed distributors that are permitted to transport and sell finished cannabis products to cannabis retailers, from which the distributor is to collect the state required cannabis excise tax. Because distributors are an integral link in the state licensed cannabis chain, on June 23, 2020, the City Council will consider adopting an ordinance permitting cannabis distribution facilities to operate in the industrial zone in the City, and establishing a process by which distributors can obtain regulatory and conditional use permits to operate in the City. The regulatory and zoning provisions of the ordinance pertaining to distributors are currently drafted so that they will only go into effect if the Banning voters approve a tax measure imposing taxes on distribution facilities.
- E. The City of Banning seeks to require all cannabis businesses, as such term is defined in this Ordinance, to pay their fair share of taxes to fund vital City services.
- F. Sections 37101 and 37100.5 of the California Government Code authorize the City to levy a tax on businesses operating in the City for revenue purposes.
- G. The City Council estimates that this tax on cannabis distribution could generate between \$20,289 and \$405,790 annually, based on an analysis of the amount of tax that cannabis distribution facilities generate in other cities.
- H. The People further declare that this tax shall be levied for unrestricted general government purposes and shall be levied only if approved by the majority of the voters voting on this Ordinance at the November 3, 2020 General Municipal Election.
 - **SECTION 2.** Chapter 3.17 of Title 3 (Revenue and Finance) of the Banning Municipal Code is hereby renamed as "Cannabis Industrial Tax".
- **SECTION 3.** Section 3.17.010 (Purpose.) of Chapter 3.17 (Cannabis Industrial Tax) of Title 3 (Revenue and Finance) of the Banning Municipal Code is hereby revised as follows, with additions shown in underline, and deletions shown in strikethrough text:
- "This Chapter shall be known as the Cannabis Business Tax. It is the intent of the voters to permit the collection of such tax at the maximum rate allowed by state law from every commercial cannabis cultivation, manufacturing, <u>distribution</u>, and laboratory testing facility operating in the City regardless of whether the cannabis business is operating lawfully under State or local law. Nothing in this Chapter shall be interpreted to authorize or permit any commercial cannabis activity that would not otherwise be legal or permissible under laws applicable to the activity at the time the activity is undertaken.
- **SECTION 4.** Section 3.17.020 (Definitions.) of Chapter 3.17 (Cannabis Industrial Tax) of Title 3 (Revenue and Finance) of the Banning Municipal Code is hereby revised to revise the definition of "cannabis business" and to add a new definition for "distribution facility" as follows, with additions shown in underlined text and deletions shown in strikethrough text, with all other provisions of Section 3.17.020 remaining unchanged:
- "Cannabis business" means a cultivation facility, laboratory testing facility, or manufacturing facility, or distribution facility.
- "Distribution facility" means a business that transports cannabis and cannabis products between State licensed cannabis retailers, manufacturers,

cultivators and testing laboratories.

- **SECTION 5.** Section 3.17.030 of Chapter 3.17 (Cannabis Business Tax) of Title 3 (Revenue and Finance) of the Banning Municipal Code is hereby renamed as "Tax imposed on commercial cannabis cultivation, manufacturing, distribution, and testing laboratory facilities".
- **SECTION 6.** Subsection C of Section 3.17.030 (Tax imposed on commercial cannabis cultivation, manufacturing, distribution, and testing laboratory facilities) of Chapter 3.17 (Cannabis Business Tax) of Title 3 (Revenue and Finance) of the Banning Municipal Code is hereby revised as follows, with additions shown in underlined text and deletions shown in strikethrough text, with all other provisions of Section 3.17.030 remaining unchanged:
- "C. Every person operating a manufacturing facility, <u>distribution facility</u>, or a testing laboratory facility shall pay to the city an annual cannabis business tax in an amount equal to ten percent of the facility's gross receipts."
- **SECTION 7.** Subsection A of Section 3.17.050 (Modifications to tax.) of Chapter 3.17 (Cannabis Business Tax) of Title 3 (Revenue and Finance) of the Banning Municipal Code is hereby revised as follows, with additions shown in underlined text, with all other provisions of Section 3.17.050 remaining unchanged:
- "A. Notwithstanding Elections Code Section 9217, or the tax rate of fifteen dollars per square foot of canopy space for a cultivation facility or the tax rate of ten percent of gross receipts of a manufacturing facility, distribution facility, or testing laboratory facility, the city council may, in its discretion without the vote of the people of Banning, do any of the following:
 - 1. Reduce the tax rate for these cannabis businesses:
- 2. Increase any tax rates established by this chapter, not to exceed the maximum tax rate of twenty-five dollars per square foot of canopy space for a cannabis cultivation facility and not to exceed 10% of gross receipts of a cannabis manufacturing, distribution, or testing laboratory facility;
 - 3. Increase any rates if they had previously been reduced below such rate; and
 - 4. Establish a class of persons that is exempt or excepted from the tax or discontinue any such exemption or exception."
- **SECTION 8.** Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance for any reason is held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The voters hereby declare that they would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.
 - **SECTION 9.** Effective Date. This Ordinance shall be considered as adopted upon the date the vote is declared by the legislative body.
- **SECTION 10.** Certification. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause this Ordinance to be published in accordance with the law.

PASSED AND ADOPTED by the People of the City of Banning, State of California, at the General Municipal Election held on November 3, 2020.

IMPARTIAL ANALYSIS OF MEASURE "L"

Measure L was placed on the ballot by the Banning City Council. If approved by the voters, Measure L would adopt Banning Ordinance No. 1567 and impose an annual tax on cannabis distribution facilities in an amount equal to ten percent (10%) of the facility's gross receipts.

This is a general tax enacted for general municipal purposes such as fire, paramedic and police protection; road repairs; youth programs; and parks and recreation. All tax proceeds would go into the City's General Fund. Measure L requires a simple majority approval of the voters to pass and the tax would be effective when the results of the election are certified by the City Council.

State law allows cities to determine whether to allow commercial cannabis businesses to operate in their jurisdiction. In 2018, the City Council adopted an ordinance that allowed and regulated a limited number of cannabis retail stores. The City Council also allowed and regulated indoor cannabis cultivation facilities, manufacturing facilities and testing laboratories. All of those cannabis uses were allowed in Banning only if Banning voters approved taxes on those activities. In November 2018, Banning voters approved various taxes on those uses by way of Measures N and O. At that time, the City Council and the voters did not allow for or propose a tax on cannabis distribution facilities.

In July 2020, the Banning City Council adopted an ordinance to allow cannabis distribution facilities to operate in the Industrial zone, but only if a cannabis distribution tax is approved by the voters. A cannabis distribution facility is defined as a facility that transports cannabis goods between State licensed cannabis retailers, manufacturers, cultivators and testing laboratories. These uses would be conditionally permitted uses that are subject to various restrictions and regulations. These new regulations will be effective on the date that the City Council certifies the election results only if Measure L is approved by voters.

The amount of tax revenue generated by these taxes is dependent on the size and number of cannabis distribution businesses that operate each year and could range from a low of \$20,289 per year and potentially up to \$405,790 per year. The City Council is authorized to amend the regulatory scheme pertaining to the cannabis taxes, including changing the tax rate to a lower level without voter approval, but may not increase the rate above 10% of gross receipts without additional voter approval. This local tax is in addition to taxes collected by the State.

A "Yes" vote allows the imposition of a City tax on commercial cannabis distribution facilities and would permit currently proposed City regulations on those facilities to take effect so as to allow and regulate these types of businesses in the City.

A "No" vote is a vote against City taxes on commercial cannabis distribution facilities, and would block currently proposed City regulations from taking effect that would allow and regulate these types of businesses in the City.

ARGUMENT IN FAVOR OF MEASURE "L"

YES on MEASURE L – In 2018, voters in Banning approved Measures N & O, allowing cannabis cultivation, manufacturing, testing, and retail dispensaries within the City of Banning and imposing taxes upon these activities. Distribution is an integral part of the cannabis industry, because it involves the movement of product between the cultivators, manufacturers, testers, and retailers. Distribution activity and taxation of distribution was inadvertently left out of Measures N & O in 2018. This measure allows for cannabis distribution activity in the City of Banning, keeping this vital element of the supply chain in our city and allowing taxation of that activity.

The City of Banning depends on tax revenue to fund basic services like park maintenance, recreation programming, street maintenance, law enforcement, fire protection and general services. Depending on the level of business activity, the City of Banning can potentially generate an additional \$400,000 in tax revenue. We strongly urge a YES vote on Measure L.

Conditional Voter Registration

This process is called Conditional Voter Registration (CVR) and is commonly referred to as Same Day Voter Registration. Here's how it works:

- 1. Visit the Registrar of Voters office or any Voter Assistance Center.
- 2. Complete a voter registration card or register online at RegisterToVote.ca.gov.
- 3. Vote your ballot.
- 4. Once the county elections official processes your registration and determines you are eligible, you will be registered to vote and your ballot will be counted.

California Motor Voter

The California Motor Voter program is making registering to vote at the California Department of Motor Vehicles (DMV) more convenient and secure. All eligible individuals completing driver license or ID card or change of address transactions at the DMV will be registered to vote with the California Secretary of State unless they "opt out" of automatic voter registration.

The California Motor Voter program applies to Californians who are 18 years or older and meet the following criteria:

- A United States citizen and a resident of California.
- Not currently in state or federal prison or on parole for the conviction of a felony.
- Not currently found mentally incompetent to vote by a court.

Note: Voter pre-registration is available for those 16 and 17 years of age. Their voter registration will become active automatically when they turn 18.

Before visiting a DMV field office, we recommend making an appointment. Visit https://www.dmv.ca.gov/portal/dmv/detail/portal/foa/welcome to get started. You can also use DMV online services (https://www.dmv.ca.gov/portal/dmv/dmv/onlinesvcs) to renew your driver license or ID card or change your address.

If you indicate you're eligible to vote, once you complete your driver license or state ID renewal form transaction online, by mail or in person at the DMV, your voter information is then transmitted securely and electronically to the California Secretary of State.

Please note that drivers with an AB 60 driver's license are not eligible to participate in the California Motor Voter program and are not eligible to vote.

Remote Accessible Vote-by-Mail (RAVBM) in Riverside County

For the November 3, 2020 General Election, all voters will receive a ballot in the mail. Riverside County will begin mailing voters their ballots on October 5th.

You can also vote with Remote Accessible Vote-by-Mail. RAVBM lets you:

- Download, mark, and print your ballot at home
- Use your own assistive technology to read and mark the ballot
- Select the language for your ballot

RAVBM is not "internet voting." You must print and return your marked ballot.



You must request your RAVBM ballot by October 27th

How to vote from home (accessibly!) with RAVBM:

1. Request an RAVBM ballot access link

Put your RAVBM ballot in the envelope you received in the mail. Sign the voter's declaration (punched holes tell you where to sign). Seal the envelope.

5. Return your ballot

By mail. (Your envelope will include pre-paid postage!)

- a U.S. citizen living in California
- at least 18 years old
- registered where you currently live
- not currently in state or federal prison or on parole for the conviction of a felony
- not currently found mentally incompetent to vote by a court



The right to vote if you are a registered voter even if your name is not on the list. You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.



The right to vote if you are still in line when the polls close.



The right to cast a secret ballot without anyone bothering you or telling you how to vote.



The right to get a new ballot if you have made a mistake, if you have not already cast your ballot. You can:

Ask an elections official at a polling place for a new ballot.

Exchange your vote-by-mail ballot for a new one at an elections office or at your polling place, or

Vote using a provisional ballot.



The right to get help casting your ballot from anyone you choose, except from your

employer or union representative.



The right to drop off your completed vote-by-mail ballot at any polling place in California.



The right to get election materials in a language other than English if enough people in your voting precinct speak that language.



The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.



The right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's office.

Return your ballot by mail: If you choose to vote at home, you can return your ballot by mail (no postage required). Ballots returned by mail must be postmarked by Election Day and received by November 20, 2020.

Drop off your ballot: You can drop off your ballot at any secure Ballot Drop-Off box, Early Vote location, Voter Assistance Center or the Registrar of Voters office. See the list of Ballot Drop-Off locations inside this Guide, or visit our website at www.voteinfo.net for more information.

Remote Accessible Vote by Mail Ballot (RAVBM)

Accessible Vote-by-Mail provides an accessible option for voters to mark their ballots privately and independently. To complete a RAVBM ballot visit www.voteinfo.net. Your completed ballot and signed Oath of the Voter must be returned to the Registrar of Voters office to be counted. Return your RAVBM ballot by mail or at one of our secure Ballot Drop-Off locations.

VOTE IN PERSON

The Riverside County Registrar of Voters recommends that voters only use the in-person Voter Assistance Centers if absolutely necessary, as the generalized use of in-person voting presents risks to public health and safety in light of the COVID-19 pandemic.

Tips for California's Military and Overseas Voters

Taking part in elections is more convenient than ever for Californians serving in the military or living outside the United States. It begins when you register to vote as a military or overseas voter and receive election materials by mail, fax, or email.

- Start early. California's county elections officials begin sending ballots to military and overseas voters 60 days before Election Day. Fill out a voter registration application early at RegisterToVote.ca.gov to ensure that you receive your voting materials in time.
- **Know your options.** When registering to vote as a military or overseas voter, you can choose to have your ballot mailed, faxed, or emailed to you. You may return your voted ballot to your county elections official by mail or, in certain circumstances, by fax. If you meet the requirements to return your ballot by fax, you must also fax the Oath of Voter form (available from your county elections official) waiving your right to a confidential ballot.
- **Stay in touch.** Once you register as a military or overseas voter, you will continue to receive a ballot and election materials from your county elections official before each election. We encourage you to update your registration each year, if needed; however, you *must* re-register to vote if you change your address, your name, or your political party preference, or if you do not participate in four consecutive statewide general elections. Visit *www.sos.ca.gov/elections/voter-registration/military-overseas-voters/* for more election resources designed especially for you.

Dates to remember:

October 19: last day to register to vote and request your ballot

October 27: last day to update or change how you want to receive your ballot

November 3: Election Day. Mailed ballots must be postmarked on or before Election Day **and** received by your county elections office no later than November 20. Faxed ballots must be delivered to your county elections office by close of polls, no later than 8:00 p.m. Pacific Standard Time, on Election Day.

- ✓ Be a U.S. citizen or legal permanent resident
- ✓ Be at least 16 years old on Election Day
- ✓ Attend a public or private high school
- ✓ Have at least a 2.5 grade point average
- ✓ Get permission from your parents and school
- ✓ Attend a training session

- Curbside Voting on Election Day If you are unable to enter the location due to a physical disability, you may request Curbside Voting at any voter assistance center. An Election Officer will be contacted prior to your arrival to meet you at the curb.
